Name of the Journal: Journal of Social Science (JSS)

Aims and Scope

Journal of Social Science is an academic peer-reviewed journal published by the Faculty of Social Sciences at Begum Rokeya University, Rangpur, Bangladesh. This journal publishes original, empirical and innovative materials in functional and support areas of social science: It is primarily devoted to the extension and further development and dissemination of knowledge in the field of social science for the benefit of academics as well as researchers.

Coverage

Within the boundary of the above-mentioned aims and scope, the journal covers wide areas of interest in the field of social sciences. In the backdrop of global scenario, international, local and regional issues are picked up on a systematic manner to help develop the insight into the theoretical underpinnings of different social issues.

Frequency of Publication

In normal situation, the journal is published twice a year in English.

Journal of Social Science Authors Guidelines

- 1. Cover Letter: Manuscript should include a cover letter and complete contact information for the corresponding author (institutional affiliation, postal/mail address, e-mail address, and telephone/mobile), who will be responsible for communicating with other authors about revisions and final approval of the proof. Corresponding author is also requested to check whether all authors have agreed to submit the article.
- 2. Article structure: Each submitted manuscript should be prepared within the following framework.
- i. Abstract: The maximum length for the abstract is 200 words. Suggested contents: (1) background and/or problem statements, (2) purpose(s)/ aims or objectives, (3) method(s), (4) summary of key findings, and (5) contribution(s) and implication(s). The abstract is often presented separately from the article, so it must be able to stand M. 40 mars 2028 alone.

- ii. Keywords and JEL Classification: Present 3-5 Keywords and appropriate 3-5 JEL classification codes immediately after the abstract.
- iii. Introduction: The introduction should clearly justify the rationale of the study with appropriate theoretical and empirical backgrounds. This section should include the reference of existing literature, credible information and data, and any theoretical support for describing why the current study is a worthy literary work. The introduction should briefly present critical findings, contributions, and structure of the rest of the paper. If a separate literature review section is required then, it can be placed immediately after the introduction to developing the hypothesis.
- iv. Data and Methodology: This section should explain the data source (if any) and the empirical methodologies used in the manuscript. Proper reference should be maintained if the paper is produced by following any published methods.
- V. Results and Discussion: The result section should present the appropriate empirical results and make extensive discussions on the overall and critical findings. Relevant literature should be cited to reinforce the findings of the study.
- vi. Conclusion and Policy Implications: The Journal holds that every single article published must contain some specific policy implications for policy planners of the appropriate regions or countries under study. If the paper is theoretical, the idea of such paper is even more valuable. The conclusion should clearly state the significant findings of the article without much repetition.
- 3. Text Pages: Title of the paper, abstract, text of the paper, references, notes, tables and figures.
- 4. Text Range: 5000 words approximately including documentation.

- a. Paper size, A4

- c. Line Justified at both left & right margin
- d. Printed on one side of the paper.
- 6. Margins:
- a. Top: 1.00, Bottom: 1.00, Left: 1.75, Right: 1.00,
- b. Gutter: 0, Gutter Position: Left
- c. Header: 0.5, Footer: 0.5
- d. ½ Inch indent at the first line of every paragraph,
- e. 1 line indents at both sides of the page for the page for the set- off quotations (above 3 lines)
- 7. Line Spacing:

Hard copy and soft copy: Double- Spaced throughout the paper, including quotations, notes and references.

- 9. Heading and Title:
- a. First letter of every word in heading and title should be capitalized.
- b. No full-stop after any heading or title.
- c. Title must be put 18 Font under the top margin of the page.
- 9. Page Numbering. Bottom right- hand corner.
- 10. Spelling: Either British or American Style of spelling can be followed but mixing of these two will not be entertained.

- 11. Abbreviations: If abbreviations are used in the text, please defined it in the text where first used.
- 12. Tables and Illustrations:
- a. Source or any notes to be given immediately below the table,
- b. Single-spaces throughout the lines of the table.
- 13. Referencing: The article shall follow the APA 7th edition referencing style. Books, articles or any write-up published by unrecognized publishers, note-books, study-guides, Wikipedia, blogs, and any untrusted website cannot be used as references in research articles.
- 14. Footnotes: Authors are discouraged to use footnotes. However, if it is essential, please put it at the end of the article before the reference section.
- 15. Acknowledgement: Any acknowledgements-specified or anonymous authors should be included in a separate headed section at the end of the manuscript. Please do not incorporate these into the original paper.
- 16. Book Review: For book review, two copies of book should be sent to the Editor.
- 17. Authorship and Authenticity: For authorship (also for joint authorship of the same paper), a declaration of Authenticity (including name(s), designation & Signature on a separate sheet of paper) is a must.
- 18 Submission: The soft-copy of the article is to be submitted to editor.jss@brur.ac.bd.

- 19. Plagiarism: If the plagiarism is detected more than 20% in any article(s), it is found that the authors are very unlikely to revise the article and submit the revised version.
- 20. Number of Authors: The number of authors of jointly written articles must not exceed more than three.
- 21. Author's Copy: The author(s) will get one copy of published journal along with 3 copies of off-print.
- 22. Copyright: Editor, Journal of Social Science at Begum Rokeya University, Rangpur, reserves full copyright of all published works.
- 23. Withdrawai Policy: If any author(s) would like to withdraw any article, must follow the procedure. If before sending to any Reviewer, Tk. 1000 BDT will be charged, and after sending the article to any reviewer, Reviewer's charge must be born to the author.
- 24. Note: Paper(s) that will not follow the guidelines will be returned to the author(s) for correction and re-submission.
